LABC 2020/21 Budget Uncertainty:

Significant uncertainty was introduced to the 2020/21 budget development process from November 2019 through March 2020:

In November 2019 LABC was asked to prepare a status quo budget with allowance made for the cost implications of the ALL/LSS/ AG tariff settlement.

On December 13, 2019 the board passed that budget and forwarded it to the AG along with 70 pages of supporting information requested by the Ministry.

On January 17, 2020 the budget was rejected and LABC was asked to prepare proposals for up to \$5.86 million of funding reductions.

In February further budget reduction proposals were requested.

In early March Ministry staff asked LABC to take no action to address possible budget reductions and LABC was advised that recent interest rate reductions will result in a significant revenue reductions to the Law Foundation and Notary Foundation.

In mid-March the Federal Government delayed the introduction of its own budget and BC asked all Crown agencies to refrain from laying off any staff for at least two months.

The CEO has kept the Chair updated and sought advice from the Board on strategies and priorities.

The CEO has kept the Federal Government advised that current provincial funding for immigration legal aid will not be sufficient to maintain services through the year.

The LABC Board relies on the Executive Committee to assess political risks and the Finance Committee to oversee financial risk management issues.

Tariff withdrawal of services

In February 2019 LABC was facing a withdrawal of services by private lawyers who accept legal aid contracts. In March 2019 the Association of Legal Aid Lawyers (ALL) agreed to negotiate a settlement based on an interim agreement that included a commitment to negotiate and a 25% increase to legal aid fees for the negotiation period from April 1, 2019 through November 2019. The increase was funded by liquidating the LABC accumulated surplus with a matching amount contributed by government. The Law Foundation managed those payments to lawyers.

In the fall of 2019 ALL, LSS and BC reached an agreement on outstanding issues that included an ongoing consultation on legal aid eligibility and coverage issues.
