Response from Heidi Mason, Director Legal Advice & Representation regarding recent BCMA increase

We've received feedback on LSS's long-standing policy of matching the British Columbia Medical Association (BCMA) rates for medical-legal reports and medical expert testimony. (Refer to Notice to Counsel #89.)

Our policy of matching the external government rates extends back to the 1980s. The rationale for matching the BCMA rates is as follows:

- LSS ensures referral lawyers will have access to medical experts.
- BCMA rates provide an objective and fair rate of reimbursement to medical practitioners without the administrative burden of negotiating on a case-by-case basis.

The cost impact of matching the rates is minimal, considering LSS's overall disbursement budget — the estimated cost impact this year is \$4,000 or 0.006 percent of total tariff expenditures.

Appeals Department update



We're pleased to announce that Michael Smith has joined the Appeals Department as a managing lawyer, working with Managing Lawyer Rod Holloway. Michael articled with LSS in 1998 and since then has continuously been one of our Appeals Assessment lawyers. He was a key part of the team that conducted an extensive review of the LSS tariff in 2005, resulting in the *Managing for Results* report. We're also pleased to confirm that Camran Chaichian continues to be the managing lawyer, Criminal Law. After further consideration, Camran withdrew the resignation he had tendered earlier.

We're pleased to introduce Trish Kumpf as the new manager, Aboriginal Services. Trish joins us from Victoria

and brings extensive legal and management experience to this position. Under Trish, the LSS Gladue disbursement pilot project is being extended for the 2014/15 fiscal year. But due to extremely limited funding, the number of reports approved monthly are minimal and approvals are discretionary and subject to available
